

Terms & Conditions for IASRI RECRUITMENT-2016

1. Payments

All payments made in order to apply for the LDC and Technical Assistant posts must be paid in full to ensure submission of application. Once payment has been received, an acknowledgement page will be generated wherein information regarding the payment of fees will be displayed. If payment is not made at the time of booking, application will be considered incomplete and void.

2. Cancellation Policy

Once the payment of fees has been made and the application is submitted, the fees will not be refunded in any case. If the candidate has wrongly made payment for one post and later on requests to adjust the fees paid for another post, such request won't be entertained. Similarly, the payment made for the current batch of recruitment process will not be adjusted in future vacancies.

3. Registration Information

All candidates are required to have a working email at the time of registration. Registration information will be sent to registered candidates by email.
